A. APPROVAL OF MEETING MINUTES

C. DISCUSSION ITEMS

1. November Service Changes (Tony)

Tony gave a brief update of the November service changes. Adjustments made to reflect real time scheduling.

2. FY25 Budget & Service Planning (Erin)

Erin updated the committee on the FY25 budget and planning.

The commission has agreed to fund the fiscal deficit with a look to see how we can restructure routes in the suburb areas.

Public Input meetings have been scheduled to get feedback on what changes would best serve DART and the suburban areas.

No impact to Paratransit currently.

The city of Des Moines is looking at options:

No change, which will lead to a \$7.7M deficit to DART.

 A 2.5% Franchise fee increase would generate \$6.5 million of the needed funds and will lower property taxes for several years. The franchise fee is a short-term solution as the property tax levy would increase and be back at the cap in about five years.

If DART reduces service: D-Line and Link will be discontinued, frequency of service would change on most routes including the elimination or reduction of some Saturday and Sunday service.

Public Input:

- Input Meeting focus will be on all DART riders and taxpayers in the city of Des Moines.
 - i. Educate about the possibility of service reductions.
 - ii. Educate public about how much taxpayers currently invest.
 - iii. How do we allocate the resources DART has?
 - iv. Can the homeowner slide be altered to accommodate for renters who don't pay property taxes?
