DART collecting public feedback on major service changes

DART proposing to introduce first-ever crosstown route and major schedule changes

The Des Moines Area Regional Transit Authority (DART) is collecting input from the public as it plans to make major changes to its service in August 2018. These proposed changes include:

- 1) adding service along Euclid and Douglas Avenues in north Des Moines through DART's first-ever crosstown route;
- 2) making major schedule changes to start service earlier and improve midday frequency for riders on many Local Routes;
- 3) re-routing Local Route 10 – East University to serve Iowa Lutheran Hospital; and
- 4) updating schedules to reflect new bell times for Des Moines Public School District (DMPS) students.

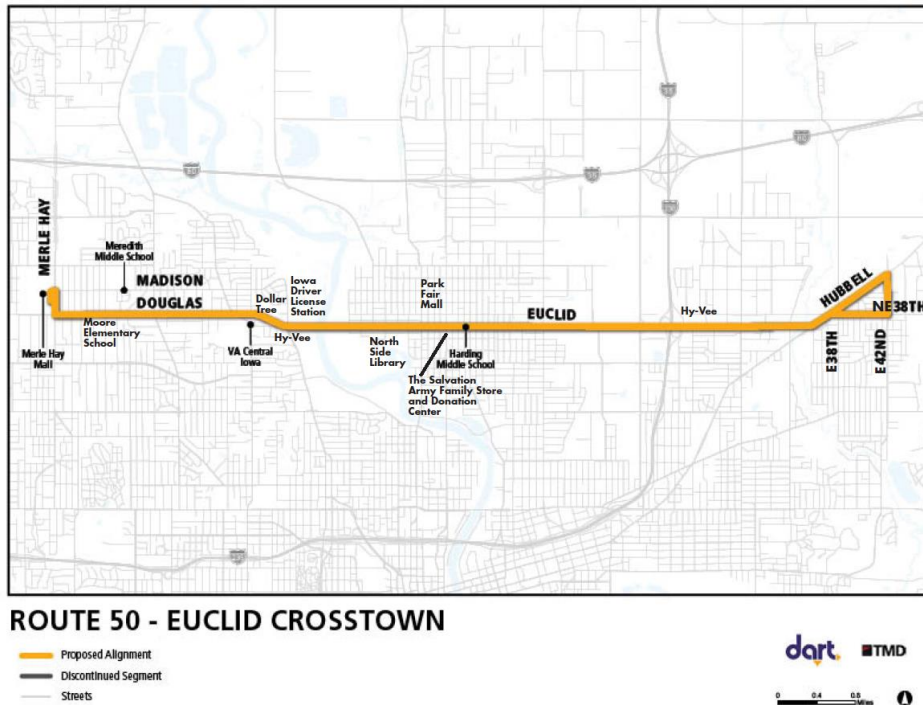
Proposed August 2018 service changes

1. Local Route 50 – New Euclid Crosstown

DART is proposing to begin service on its first-ever crosstown route in August 2018. This route will travel east and west along Euclid and Douglas Avenues in north Des Moines between E 42nd Street and Merle Hay

Road, allowing riders to travel along the corridor without having to come downtown to transfer routes at DART Central Station.

DART is planning for service to operate every 40 minutes on weekdays between 5 a.m. and 11 p.m. This new route will travel past transfer points for seven other Local Routes.

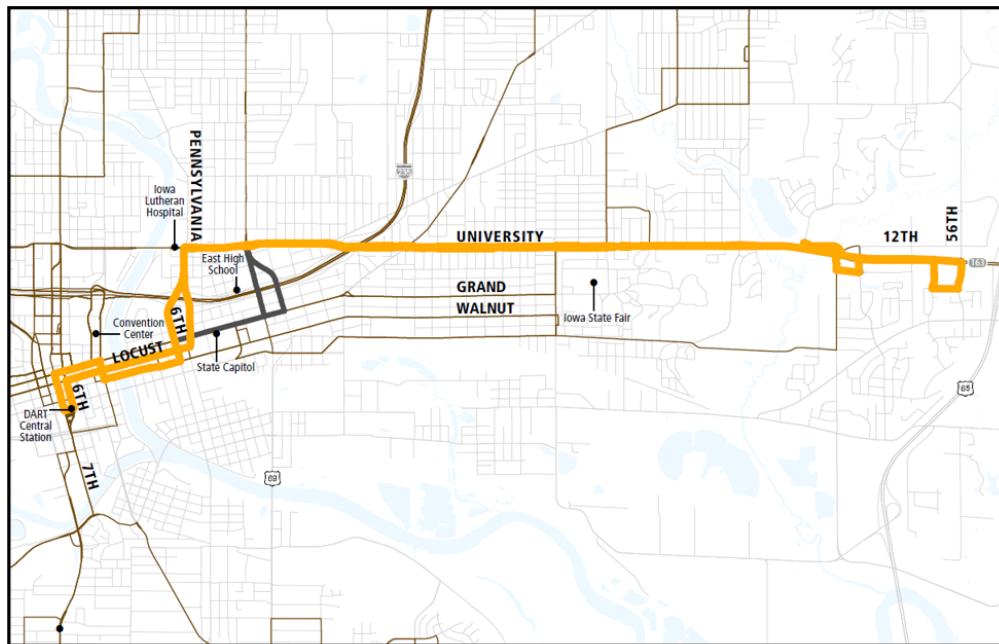


2. Major schedule changes to improve frequency and begin service earlier on key Local Routes

DART staff has been evaluating service on all routes and is proposing changes to schedules to provide better service throughout the day to our riders. The proposed changes include starting service on some Local Routes earlier on weekdays so area employees can get to work by 6 a.m., and providing more mid-day frequency on several Local Routes. Proposed frequency changes for impacted routes are available now on ridedart.com.

3. Route modification for Local Route 10 – East University

DART is proposing changes to Local Route 10 – University Avenue to expand coverage in Des Moines. The proposed route would serve Iowa Lutheran Hospital, and would not travel to the Iowa State Capitol Complex. The discontinued portion of the route would still be served by other DART routes.

4. Adjustments to school-related trip times

DART is adjusting schedule times for school-related trips to provide transportation for middle and high school students in the Des Moines Public School (DMPS) District that matches the new school start and end times adopted earlier this year.
